



FIRE PREVENTION

Welcome to June 2025 and the realization that 2025 is now half over!! Time sure is moving fast! June 2025 was a very busy month in Fire Prevention on a couple of fronts. Inspections and Preplans using our NEW First Due software.

Inspections:

Starting this month, I have started to collect data to use with our new RMS system called First Due. Part of that data collection includes some elements of the preplan system. The idea is, if I collect contact information as well as building information on each of the inspectable properties/buildings, all that data will be available for the shift personnel to use. When I fill in contact information, that information is applied to every file we have on that particular building. When I or the shifts inspect a building, the contact information will populate portions of the Inspection Report as well as the Preplan form. The problem is that contact information needs to be added in by hand the first time and after that, will only need to be verified or updated on an annual basis.

Preplanning:

Preplanning or building surveys have been part of the fire department's annual training for decades. Over the years the process of data collection and the forms have been updated to include contact information, building hazards, fire protection systems, access problems, utility locations and other information relating to the building. When we migrated to First Due that information evolved into a very large document. That document, however, now provides every department member with information that they can use to better understand the building and any associated hazards that they may not see from the curb. I have successfully created nearly 60 new Preplans for our members. Until I can get all the new data imported into the system, the department members can still access the older preplans.

Public Education:

June was a busy month for events that the Fire Department played a key role. Chief Gaertner and I participated in a raffle from Willard School where two winners bid to become "Mayor for the Day". The two winners took part in the day-to-day activities of running the Village. They sat in on a mock Board Meeting where they listened to a few ideas and then voted on two new ordinances. One was to have candy on Fridays and the second was to always have desserts on Sunday. You can only imagine that Village Staff will gladly enforce these new ordinances! They also sat in on a Village Staff Meeting. They had extended tours of the Fire House, Police Station and the parts of the Village Hall that nobody else can see. As a finance exercise, they were asked to divide a set amount of money amongst the various departments that comprise the village staff. I am happy to say that they took this task to heart and gave the bulk of the money to the Fire Department!

The Fire Department provided some attention seeking noise in the form of a parade with Lights and Sirens blaring, down Lake St for the OPRF Girls Softball Team who were on their way to represent the two towns in a State Tournament.

The Fire Department also participated in the Wounded Warrior Bike Ride by displaying a huge American Flag hanging 40 feet in the air for all the riders in support of this annual tradition.

The Fire Department also participated in the ceremonies for the Pride flag and Juneteenth flag raisings.

During the last week of June, the fire department teamed with Concordia University for the second year in a row, to present a Nursing Camp to approximately 20 Junior High and High School aged kids. The camp was held at the Christopher Center's new Nursing training facility. Deputy Chief Bochenek, with assistance from Lieutenant Quentin Boyd and other department members presented a number of classes such as patient assessment, performing vital signs in a stressful situation, patient packaging and the transport of sick and injured patients over the five days of the camp. The students also participated in scenarios to reenforce the close working relationships Paramedics have with the area hospital nurses and emergency room staffs. The students were also offered a down and dirty CPR and Stop the Bleed class, as well as a demonstration of an auto accident and extrication scenario. Despite a week of hot weather, the camp was a HUGE success, and the reviews of the camp, as well as the Fire Department were extremely high. We think this may be the beginning of a grassroots campaign to attract young people into the Firefighter/Paramedic programs, as well as Nursing programs.

The last item in my monthly report is a summary of activities that do not fit in any other category such as, hydrant flows for sprinkler companies, servicing a Knox Box, public education flyers, and picking up and/or dropping off vehicles for service among others. These activities may not be difficult but do take up time that I like to account for.


Concordia University Nursing Program "Envision Nursing Camp"


The week of June 23rd through the 27th saw the second run of the ENVISION Nursing Camp at Concordia University here in River Forest. The camp was the recipient of a state grant that aims at teaching kids in the community about the various aspects of the medical field. From being a first responder EMT, to performing a procedure with a Laparoscopic surgical device, these participants were thrust into an immersive and simulated driven camp like no other.

The participants experienced many hands-on exercises that challenged them mentally and physically, while giving them a safe environment to handle medical and rescue equipment. Students learned skills that firefighter/paramedics perform in the field as well as many skills nurses perform in a hospital setting. These skills included performing intraosseous placement (drilling into bone), pleural decompression (placing a needle into the lung), and intubation skills (placing a breathing tube into the trachea) just to name a few. After learning the skills of a first responder/paramedic, the kids were transported to a nursing environment. Skills like medication administration, suturing, and Laparoscopic surgery were among the new skills experienced by camp participants.

This camp went so well that the organizers, which included 2 members of the fire department and 3 members of the Concordia nursing staff, were invited to the International Simulations in Healthcare Conference in Florida in January of 2025. Concordia's nursing staff led by Director Kristen Bayer and Laurie Zack, secured a state grant to help offset some of the cost of the camp for this year's participants. The camp was truly a community effort as the River Forest Police Department and Public Works also contributed to the success of the event.


