Crime Statistics

The month of September 2025 indicated a 19% decrease in Group A offenses in comparison to September 2024. Group A offenses year to date show an increase of 19% from the same period in 2024. There was a 29% decrease in Group B offenses compared to September 2024. This decrease is due to a reduction in retail theft incidents in September 2025

The Police Department responded to sixty-six (66) calls for service at the Town Center properties in September 2025; of those calls there were thirty-one (31) reported crimes, which included sixteen (16) Retail Thefts and five (5) Panhandlers/Removals. There was a fifteen percent (-15%) decrease in calls for service in comparison to September 2024 statistics. In addition, there was a thirty-three percent (-33%) decrease in retail thefts in comparison from September 2024.

Community Policing/Crime Prevention Activities:

- Officers conducted additional patrols and premise checks in the business districts, parks, school play areas, block parties, and the library.
- Officers conducted numerous traffic missions in locations that have been identified as priorities based on traffic crash data and citizen requests.
- Officers conducted daily School Enforcement at all D90 schools and private schools.

Directed Patrols/ Traffic Enforcement

The Midnight Shift focused traffic enforcement using saturation enforcement techniques on North Avenue. Officers made forty-nine (49) stops, issued fifty-three (53) citations and seventeen (17) warnings during their traffic missions. The shift made six (6) traffic arrests, and six (6) vehicles were administratively towed during the enforcement traffic missions.

Dayshift focused traffic enforcement on Thatcher Avenue and on Washington Boulevard. Officers made twenty-nine (29) stops, issued thirty-four (34) citations and fourteen (14) warnings. The shift recorded eight (8) traffic-related arrests during enforcement missions this month. Six (6) vehicles were administratively towed.

The Afternoon Shift focused their traffic enforcement efforts primarily in school zones on Lake Street, Division Street, and on Chicago Avenue. Officers made twenty-two (22) stops, issued sixteen (16) citations and eleven (11) warnings during traffic enforcement missions. The shift recorded two (2) traffic-related arrests and administratively towed two (2) cars.

Notable Events and Arrests:

25-01059 Driving Under the Influence

On September 2, 2025, 2:06AM, River Forest officers were dispatched to the area of Lake Street and Harlem Avenue regarding a vehicle stopped in traffic with the driver asleep at the wheel. The driver, a 29-year-old male from Chicago, was contacted, exhibited signs of alcohol impairment, failed Standardized Field Sobriety Tests, and was arrested for Driving Under the Influence of Alcohol. He was processed and later released on a Citation and Notice. The vehicle was towed with an administrative hold placed on the vehicle.

25-01067 No Valid Driver's License & DuPage County Warrant

On September 1, 2025, 10:34AM, A River Forest officer was conducting traffic enforcement on Lake Street when he was alerted by a License Plate Reader (LPR) for a vehicle with suspended registration. The information was verified, and a traffic stop was conducted on the vehicle in the 7400 block of Lake Street. The driver was identified as a 27-year-old female from Melrose Park. The driver was determined to have never been issued a license and was arrested. The driver was also determined to have an outstanding active Warrant out of DuPage County for failure to appear on a traffic offense. The driver was processed and released on a Citation and Notice and posted bond on the warrant. The driver was given a court date at the Maybrook Courthouse as well as a court date for the DuPage County Courthouse.

25-01079 Driving While License Suspended

On September 5, 2025, 1:06AM, a River Forest officer conducting traffic enforcement near Division Street and Thatcher Avenue observed a vehicle driving 53mph on Thatcher Avenue where the speed limit is 25mph. The vehicle was stopped and the driver, a 39-year-old male from Chicago, was found to be driving despite never having been issued a driver's license. He also had a suspended driving record, with two suspensions for failing to appear in court after a prior traffic violation and mandatory insurance violations. He was arrested for Driving While License Suspended, processed, and later released on Citation and Notice. The vehicle was towed with an administrative hold placed on the vehicle.

25-01101 Retail Theft & Outside Agency Arrest Warrant

On September 8, 2025, 4:40PM, River Forest units were dispatched to 7525 Lake Street (Jewel-Osco) for the Retail Theft that just occurred. The employee advised two offenders, working in concert, concealed items and fled the store without purchasing the merchandise valued at \$72.45. A suspect matching the description of one of the offenders was located in the 7300 block of Central Avenue. The employee positively identified the suspect as the offender assisting in the Retail Theft. The offender was arrested and identified as a 35-year-old male from Maywood. The offender was transported to the station for processing, and a custodial search revealed the offender possessed drug paraphernalia and a small amount of a controlled substance. It was also determined that the offender had an outstanding McDonough County Arrest Warrant for Possession of a Controlled Substance. The offender was charged with Possession of a Controlled Substance, Possession of Drug Paraphernalia, Retail Theft, and the outstanding Warrant. The offender was given a felony court date and transported to a detention hearing.

On September 8, 2025, 8:26PM, River Forest units were dispatched to 624 Harlem Avenue (McDonald's) for the disturbance in-progress. The employee advised the offender was irate after the offender's credit card was declined. The employee stated the offender spat in her face and made threats of violence. The employee stated she walked away, and the offender continued to make threats of violence towards the patrons inside the restaurant. The offender then fled the scene on foot northbound on Harlem Avenue. A suspect matching the description was located at 1020 Harlem Avenue. The employee positively identified the suspect as the offender. The offender was arrested and identified as a 54-year-old male from Dixmoor. The offender was transported to the station for processing and charged with Disorderly Conduct and Aggravated Assault. The offender was given a misdemeanor court date and released on Citation and Notice.

On September 11, 2025, 12:48AM, a River Forest officer conducting traffic enforcement near Lathrop Avenue and North Avenue observed a vehicle driving 42mph on North Avenue where the speed limit is 30mph. The employee advised the offender stole alcohol and fled the scene. A suspect matching the description was located at North Boulevard and Harlem Avenue. The River Forest unit was the first unit on scene, and observed multiple subjects, wearing all black clothing, actively committing a burglary. The subjects fled in a reported stolen vehicle, and the River Forest officer assisted several different police agencies in following the vehicle until it stopped in Maywood. The subjects fled on foot and the River Forest officer assisted with locating and detaining three of the male subjects. The males and vehicle were turned over to the custody of Oak Park Police for a Burglary, Traffic, and Possession of a Stolen Auto investigation. When the male offenders were turned over to Oak Park Police, their ages and hometowns were unknown and pending verification.

25-01138 Retail Theft & Criminal Trespass to Real Property

On September 16, 2025, 6:26PM, River Forest units were dispatched to 7525 Lake Street (Jewel-Osco) for the Retail Theft that just occurred. The employee advised the offender stole alcohol and fled the scene. A suspect matching the description was located on the 400 block of Harlem Avenue. The employee positively identified the suspect as the Retail Theft offender, and the merchandise valued at \$145.18 was recovered. The offender was identified as a 38-year-old male from Chicago who had received a prior Criminal Trespass warning from Jewel-Osco. New Investigations

25-01051 Retail Theft

On August 31, 2025, 1:44PM, River Forest Officers responded to Walgreens located at 7251 Lake St. in reference to a retail theft which just occurred. The store employee related that a female subject stole approximately \$400 worth of electric shavers from the store and provided the registration of the offending vehicle that the female used to leave the scene. Investigators located the vehicle in Chicago and towed it with an administrative hold. This case was exceptionally cleared.

25-01065 Burglary

On September 3, 2025, 8:48AM, a River Forest Officer responded to the 8200 block of Lake St. in reference to a burglary report. The resident related that between September 2, 2025, at 9:30PM and September 3, 2025, at 8:30AM, an unknown person entered his detached garage and stole two bicycles.
