IV. PROPOSED REWRITE OF THE VILLAGE HISTORIC PRESERVATION ORDINANCE - REVIEW AND DISCUSSION

The Commission, together with Deputy Clerk Masella, reviewed the redlined version provided for the meeting on a page-by-page basis. The Commission discussed and recommended edits for Deputy Clerk Masella to incorporate into a revised draft to be presented at the next meeting.

Among the requested revisions were several items based on the Commission's feedback, including implementing consistent capitalization throughout the document, ensuring the proper use of the term "principal structure," restructuring and expanding sections related to hearings for local landmark designations, refining language for improved clarity and flow, reviewing the demolition delay timeline, and discussing the use of certified mail notifications. These represent some of the topics discussed, as additional and other details were also reviewed throughout the meeting.

The Commission directed Deputy Clerk Masella to create a second draft for review at their next meeting.
