Monday, December 12, 2022**

A regular meeting of the Village of River Forest Board of Trustees was held on Monday, December 12, 2022, at 7:00 p.m. in the Community Room of Village Hall, 400 Park Avenue – River Forest, IL.

1. CALL TO ORDER/ROLL CALL

The meeting was called to order at 7:04 p.m. Upon roll call, the following persons were:

Also Present: Village Administrator Brian Murphy, Assistant to the Village Administrator Matt Walsh, Fire Chief Thomas Gaertner, Police Chief James O'Shea, Finance Director Rosemary McAdams, Director of Public Works and Development Services Jeff Loster, Village Attorney Lance Malina, Deputy Clerk Luke Masella.

2. PLEDGE OF ALLEGIANCE

President Adduci led the pledge of allegiance.

3. CITIZEN COMMENTS (OCCURRED AFTER ELECTED OFFICIAL COMMENTS & ANNOUNCEMENTS)

Phyllis Rubin, of 411 Ashland Ave., wished everybody a happy Christmas, New Year and Hanukkah and then remarked that there has been some activity at the Lake and Lathrop property recently, but going very slowly. She mentioned that the site is untidy and appears poorly regulated, particularly that there are sandbags blocking portions of the sidewalk which will cause a tripping hazard when they become covered by snow in the coming months. Phyllis also conveyed a request from one of her neighbors that during the winter months, the sidewalks should be shoveled the entire width of the sidewalk, not just one shovel's width.

4. ELECTED OFFICIAL COMMENTS & ANNOUNCEMENTS

Trustee Bachner began with a land acknowledgment. Trustee Bachner reported that she attended the annual Holiday Tree Trimming event on Lake Street, hosted by the Rotary Club, and complimented the event. Also attended the Holiday Bazaar at the Sheridan. Additionally, Trustee Bachner attended an event hosted by the Oak Park River Forest Association of Realtors and complimented the event. She also commented that she participated in an event sponsored by the Chicago Accessibility

Consortium regarding the state of current disability rights and activism. Trustee Bachner also participated in an event put on by Dominican University with the author of the book, *Braiding Sweetgrass*, and enjoyed the event.

Trustee Gillis congratulated The Sustainability Commission, Public Works Analyst Seth Jansen and Director of Public Works Jeff Loster for being a part of the second annual Electric Vehicle (EV) Readiness group sponsored by the Mayors Metropolitan Caucus and ComEd. Trustee Gillis reiterated the importance of the village completing an EV readiness study to be prepared for the EV Readiness requirements. Trustee Gillis reminded everyone that the Light Up the Night event is taking place this Saturday, December 17th. She also attended some student final presentations at Dominican University as a guest evaluator where students proposed environmental recommendations for larger corporations. Trustee Gillis also reported that the reoccurring GreenTown meetings are continuing to make progress. Trustee Gillis finalized her comments with a happy holidays, Christmas, Hanukkah and Kwanzaa.

Trustee Vazquez reported that he attended the Village Hall staff holiday luncheon and appreciated the event as it recognized various employee anniversary dates. He reiterated how thankful he is for all the village employees and the hard work they put in every year. Trustee Vazquez wanted to remind everyone that the School District 90 Kindergarten survey is still open and that the survey is not limited to residents with students currently in the school district. Lastly, Trustee Vazquez wished everyone a safe and enjoyable holiday.

Clerk Keller had nothing to add to the permanent record.

Trustee Brennan reported she too attended the *Braiding Sweetgrass* book event at Dominican University with Trustee Bachner and attended the Village Hall luncheon. Trustee Brennan also attended the Staff Appreciation Lunch and acknowledged Fire Commander Jim Greenwood for 25 years of service. She also appreciated the sweater worn by Assistant to the Village Administrator Matt Walsh during the event. Trustee Brennan also gave an update on the Juneteenth Coat Drive, reporting that the drive has donated over four hundred of coats, sweaters, and other winter clothing. Due to this success, she stated that the coat drive has been extended another week.

Trustee Johnson wished everyone a happy holiday season and shouted out to members of Fenwick High School AP government class, who attended the board meeting.

President Adduci wished everyone a Happy Holidays and also reiterated that the Light Up River Forest event is December 17th. This is a great fundraiser for the Kiwanis Club. She also emphasized the District 90 Survey as mentioned by Trustee Vazquez. Additionally, President Adduci reported she attended and enjoyed her first Illinois Municipal League board meeting.

7.a.1. Zoning Board of Appeals Approval of Zoning Variation Request for 935 Franklin Avenue pursuant to section 10-9-7 of the Zoning Code – Front Yard Setback – Ordinance

MOTION by Trustee Vazquez to approve an ordinance granting a front yard setback variation to allow the construction of a new home at 935 Franklin Avenue. Second by Trustee Johnson.

Assistant to the Village Administrator Matt Walsh gave a summary of the application explaining that the project is for the new construction of a home and that there were no negative comments from the public. Additionally, the application was approved unanimously at the Zoning Board of Appeals.

MOTION by Trustee Johnson to approve an ordinance granting a front and side yard setback variation at 7227 Thomas Avenue. Second by Trustee Brennan.

Assistant to the Village Administrator Matt Walsh gave a summary of the application explaining that the project is to enclose an existing terrace due to some leakage issues. Matt reported that there were no negative public comments and it was approved unanimously at the Zoning Board of Appeals.

Village Administrator Murphy reminded everyone that this agenda item and the next item (7.a.3) are for neighboring projects owned by the same individual.

7.a.3. Zoning Board of Appeals Approval of Zoning Variation Request for 1037 Bonnie Brae Place pursuant to sections 10-10-4, 10-10-7, and 10-10-8 of the Zoning Code – Side Yard setback and Yard Occupation – Ordinance

MOTION by Trustee Johnson to approve an ordinance granting the requested variations for the property located at 1037 Bonnie Brae Place. Second by Trustee Bachner.

Assistant to the Village Administrator Matt Walsh gave a summary of the application explaining that the project is to build an additional garage on the property to help fulfill the covered parking requirements as required by the Zoning Code.

Trustee Brennan asked if any input had been received from the neighbor to the south.

Walsh reported that the village received no feedback regarding this project. And, that there were no comments from adjacent neighbors at the Zoning Board meeting.

7.a.4. Zoning Board of Appeals Approval of Fence Variation Request for 1534 Park Avenue pursuant to Section 4-8-5 of the Zoning Code - Ordinance

MOTION by Trustee Bachner to approve an ordinance granting the requested variation for the property located at 1534 Park Avenue. Second by Trustee Gillis.

Assistant to the Village Administrator Matt Walsh gave a summary of the application explaining that the property owner has a right to construct a front yard fence, as the property is zoned commercial. The applicant is requesting a variation to increase the openness of the fence and raise the fence height to 5 feet with 80% open. Assistant to Walsh reported that one resident spoke in support of the request and another resident spoke against the request at the Zoning Board.

Resident of the neighboring property Donna Murray addressed the Village Board and reported that herself and other owners in her condo building are against the increase of the fence height and that the by-right fence height of 4 feet, is in their opinion, adequate. The driveway for the condo complex is adjacent to this potential fence.

Trustee Vazquez asked Assistant to Walsh on what basis did one of the Zoning Board members vote against the application. Walsh reported that the member did not support front yard fences on any residential properties.

Trustee Gillis asked Walsh to confirm that they are currently voting on a variation to allow a 5-foot fence with 80% open. Walsh confirmed.

Trustee Brennan asked for clarification if whether landscaping improvements account towards the "openness" percentage.

Walsh and Administrator Murphy confirmed that the openness requirement does not take into consideration landscaping.

7.b.1. Traffic and Safety Commission Approval of bollard installation at the intersection of Thatcher & Oak.

MOTION by Trustee Vazquez to accept the recommendation put forth by the Traffic and Safety Commission regarding bollards at Thatcher and Oak Avenues. Second by Trustee Bachner.

Director of Public Works Loster gave a summarization of how this idea came about. Director Loster explained that there have been anecdotal reports of south bound traffic on Thatcher utilizing the parking lane to get past stopped vehicles while they wait for pedestrians to cross. The proposed bollards would help prevent this dangerous situation from occurring.

Trustee Brennan asked Director Loster if there is anything unique about this intersection that would cause the bollards to be needed vs other areas in the Village.

Director Loster reported that due to the lack of stop signs on Thatcher and the volume of traffic, combined with the fact that Oak is a popular walking to school route, create a difficult situation. He also explained that in the future this area will be part of the new Des Plaines River bike path, thus this a short-term improvement as it may end up being removed by the bike path.

Trustee Gillis requested that in the future, solutions outside of typical bollards that align with the atmosphere of River Forest should be considered.

Director Loster noted that solutions such as bump outs like along Lake Street can be considered.

9.a.1 Review and Acceptance of FY22 Annual Comprehensive Financial Report

MOTION by Trustee Gillis to accept the Village of River Forest FY22 Annual Comprehensive Financial Report. Second by Trustee Johnson.

Finance Director Rosemary McAdams provided a summary of the financial highlights of the report. Some of those highlights are as follows: Actual revenues exceed budget revenues in the general fund, income tax revenue exceeded budget revenues and sales/non-home rule sales taxes had increased as expected.

Director McAdams also highlighted that while the general fund expenditures were over the budgeted amount, most departments expenditures were close to their budgeted amount.

The Village's Audit Partner Martha Trotter, of Sikich LLP, also gave a presentation that highlighted the good financial standing of the City.

Trustee Vazquez asked Ms. Potter if it is fair to say that there are no concerns regarding the audit. Ms. Potter responded that yes, that is fair to say.

President Adduci gave thanks to the Finance staff and administrative staff for giving a refreshing and re-assuring report.

9.b.1 Approval of purchase of street cameras and related hardware/software from Griffon Systems in the amount of \$105,114 using funds from the FY 2023 Capital Improvement Fund

MOTION by Trustee Vazquez to accept the contract with Griffon Systems and allow them to install the purchased camera and related hardware. Second by Trustee Bachner.

Police Chief O'Shea gave a summary of the status of the police camera project currently and where the project is headed. He touched on many of the pieces of technology and gave examples of the cameras being used in various situations from around River Forest.

Trustee Bachner asked for clarification on a point Chief O'Shea made where he said that the software and A.I. are interconnected throughout the entire system. She was wondering if the "system" he referred to is only the infrastructure in River Forest, or if there are other areas?

Chief O'Shea clarified that it is the River Forest system only.

Trustee Johnson asked if these are the same cameras as the license plate reading cameras. Chief reported that they are not the same cameras.

Trustee Bachner asked Chief which organizations outside of police departments will have access to the data from the cameras.

Chief O'Shea responded that the following organizations will also have access to the information: Cook County State's Attorney, Public Defenders Office, United States Attorney's Office, any attorneys that provide a subpoena, and in some cases (pending redaction), FOIAS.

Trustee Johnson inquired on why some intersections get multiple cameras instead of one.

Chief O'Shea explained that due to variables such as foliage, landscaping, and how light poles are set up, some areas need two cameras for proper coverage.

Trustee Vazquez asked if there are any further plans for an expansion of cameras in the north side of town.

Chief O'Shea explained that there are future plans for the north section of the Village, but they are limited by budgetary constraints. He also expounded on the agreement they have with District 90 that can help with school issues.

Trustee Bachner asked Village Administrator Murphy if the village anticipates using TIF funds to help fund later expansions of cameras.

Administrator Murphy explained that some cameras may be funded by TIF funds due to their proximity to alleys in the northern River Forest.

Chief O'Shea continued his presentation showing examples of how this camera system aiding in solving crime in the Village.

President Adduci requested that a representative from the police department in the future give a presentation regarding the SAFE-T ACT. Ms. Adduci mentioned she was the Metropolitan Mayors Caucus and witnessed a presentation on the SAFE-T act that was very good.

9.c.1 Approval of an Intergovernmental Agreement with the Village of Elmwood Park regarding the North Avenue Streetscape Project – Resolution

MOTION by Trustee Bachner to approve a resolution allowing an intergovernmental agreement with the Village of Elmwood Park for the North Avenue Streetscape Project. Second by Trustee Vazquez.

Village Administrator Murphy gave a short summary of the agreement between the two villages. The streetscape plan for North Avenue will take place between the streets of Harlem and Thatcher.

Village President Adduci asked for clarification if this project is just for the stretch of North Avenue between Thatcher and Lathrop or the entirety.

Administrator Murphy confirmed it is for the entire stretch of North Avenue, from Harlem to Thatcher.

President Adduci asked for further information on the source of the money being utilized for this project.

Administrator Murphy reported that the money from our portion will come out of the North Ave TIF district. He added that this improvement may position us to go after larger grant funds.

Trustee Bachner asked if this plan is only for a portion of the streetscape and whether the improvements would calm traffic.

Administrator Murphy explained that the project will focus on the entirety of the street and that it is anticipated this project will help calm traffic.

Trustee Brennan asked for clarification if the study did not consider adding additional pedestrian crossings on North Avenue?

Administrator Murphy stated that is correct and that the study is focusing on making improvements as allowed by IDOT.

Trustee Brennan also pointed out a potential issue with the writing in the contract for this agreement regarding payments to the vendor.

Village Lawyer Lance Malina stated he will review the writing and address it. Attorney Malina recommended the motion be amended to be subject to Attorney revisions.

Trustee Vazquez amended his motion to be subject to attorney review and revision, seconded by Trustee Bachner,

Crime Statistics

The month of December 2022 indicated an 10% increase in Group A (previously Part I) offenses in comparison to December 2021. There was a 22% decrease in Group B (previously Part II) reported crimes compared to December 2021. An increase in Burglary and Motor Vehicle Theft incidents contributed to the increase in Group A crimes. A decrease in Criminal Damage and All Other Offenses incidents contributed to the Group B decrease. We will continue to report any anomalies in data or statistics next calendar year (2023).

Town Center

The Police Department responded to fifty (50) calls for service at the Town Center properties in December 2022; of those calls there were eight (8) reported crimes, which included one (1) Burglary to Motor Vehicle and seven (7) Panhandler/Criminal Trespass incidents. There was an 8% decrease in calls for service in comparison to year-to-date 2021 statistics. In addition, there was an 39% decrease in Criminal Activity in comparison to year-to-date 2021 statistics.

Traffic Enforcement

The Midnight Shift focused enforcement efforts based on mapping data related to traffic accidents. The Dayshift was assigned traffic enforcement missions on Division Street, Thatcher Avenue, and the Northeast section of the Village. The Afternoon Shift conducted enforcement missions on Chicago Avenue, Lake Street, Madison Street, Thatcher Avenue, Washington Boulevard and the Northeast section of the Village.

The Midnight Shift made eighty-eight (88) stops, issued forty-seven (47) citations, and made one (1) DUI arrest and traffic (6) traffic arrests. Five (5) vehicles were administratively towed.

The Dayshift made fifty-nine (59) stops with twenty-four (24) citations and fifty (50) warnings issued during Traffic Enforcement Missions. The shift also recorded one (1) traffic-related arrest during enforcement missions. One (1) vehicle was administratively towed.

The Afternoon shift made one hundred and nine stops (109) stops with seventy-four (74) citations and sixty-one (61) warnings issued during Traffic Enforcement Missions. The shift recorded ten (10) traffic-related arrests and eight (8) administrative tows.

Significant Incidents and Notable Arrests:

22-01439 No Valid Driver's License

On December 1, 2022 around 12:08AM, a River Forest officer on patrol near Harlem Avenue and Division observed a vehicle traveling at a high rate of speed with a suspended registration plate. The vehicle was stopped and the driver, a twenty one year old male from Chicago, was found to be driving despite never having been issued a driver's license. The driver also could not provide proof of insurance for the vehicle. The driver was arrested, charged with driving with No Valid DL, processed and later released on bond.

22-01449 Driving Under the Influence

On December 3, 2022 at 1:07PM, a River Forest officer was conducting traffic enforcement in the area of the 7900 blk of Washington Boulevard. The officer observed a vehicle driving recklessly, as it passed vehicles in the parking lane and disobeyed a stop sign. The officer completed a traffic stop in the area of Lathrop and Washington. The driver, a thirty five year old male from River Grove, exhibited signs of impairment and refused to perform field sobriety tests. The driver was arrested and charged with Driving Under the Influence, Reckless Driving and other violations. The driver was later released on bond.

New Investigations

22-01438 Residential Burglary

On November 30, 2022, at 4:11PM a River Forest resident from the 1100 block of Ashland reported that his residence had been burglarized between 1:40PM and 4:00PM that day. The offenders did not take anything from the residence, but entry was made, and the residence was rummaged through. This case is active pending any leads.

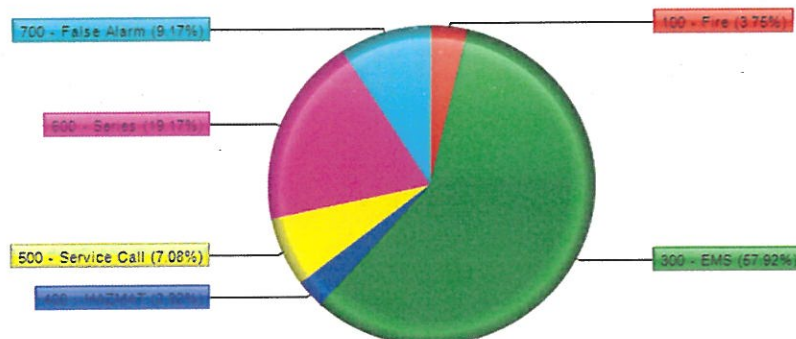

FIRE PREVENTION BUREAU **December 2022 and YTD**

As we have talked about in several monthly reports, December was the last ISEARCH Assemblies for 2022. 2022 was the best of two worlds when it came to our Public Education Safety Assemblies. We were able to use the video that Ben Ransom put together as a pre-test/post-test for the assembly. Some of the teachers would show the video as much as two weeks prior to our live assembly. We would then come in and see how much they retained and could come up with some correct answers. Now, the video does not contain all of the material from the live assembly, but we think the kids bought in to the material and the exchange between all of us was very beneficial. Another offshoot to this way of teaching was we were able to use the video to enhance the learning and comprehension of the material at times when we were not available to do live assemblies. We will be making sure that all schools and all classes have the video in 2023.

Included in this month's report are the breakdown of our Public Education contact numbers. We had contact with 2256 children and 768 adults in the various programs that the Fire Department is all involved.

The December report is also the Year End Report of our Fire Prevention activities. Looking at the numbers it really is amazing how the year-to-year numbers are close in comparison to other years. The numbers fluctuate from year to year for a variety of reasons but for the over-all

numbers, they stay close. A marked improvement and a major goal of mine was to reduce the over-all turnaround of plan reviews. My review numbers for December are down to 4 business days and the YTD number is under 6 business days.

The holiday timeframe is also a time for the annual Employee Recognition Luncheon (see pics). This year we held the event inside the Fire Station. This allows us to honor some social distancing while still maintaining the closeness of other staff departments that make River Forest a great place to work. We also held the 2nd floor Potluck lunch in December. The “White Elephant” was a very funny event. Mike Thomasino from the Water Department won my “Die Hard” Trivia Contest and was awarded the Certificate and NEW traveling trophy for 2022. The winner has the honor of proudly displaying the trophy and certificate in their workspace for the next year. The end of year is also the time when I take some time to be with my family and enjoy the spirit of the holidays.

The last item in my monthly report is a summary of activities that do not fit in any other category such as, hydrant flows for sprinkler companies, servicing a Knox Box, public education flyers, and picking up and/or dropping off vehicles for service among others. These activities may not be difficult but do take up time that I like to account for.

Individual Shift Reports

Gold Shift Report Lt. Howe

Activities: For the month of December, Gold Shift responded to a total of 89 calls. 17 of the calls were fire related, 60 involved emergency medical services and there were 3 service calls.

Incidents/Events of Note: On December 10th, Gold shift responded to Harlem and North Avenues for a gunshot victim. Ambulance 213 provided advanced life support and transported victim in serious condition to Loyola Medical center.

On December 18, Gold shift responded to the Forest Preserve for a fight in progress that resulted in a 59-year-old woman being run over by a vehicle four times. Ambulance 213 provided advanced life support and transported victim in serious condition to Loyola Medical center.

On December 24th members of the gold shift responded to a structure fire on 77th Ave in Elmwood Park. Crew assisted in doing a primary search and assisted in overhaul and extinguishment.

Training: Gold shift had 80 hours of fire related training this month, 9 hours of EMS training for an average of 17.8 hours per firefighter. Our monthly fire training included Emergency Vehicle driver safety, AHA CPR refresher, SCBA and Responding to Electrical Emergencies.

Outside of Department Training

- FF Paul Zipperich recertified all three shifts in CPR.
- LT Howe attended Div. 11 TRT drill on confined space in Oak Park.

Inspections: Gold shift completed 3 company fire inspections in December.

Black Shift Report: Lt. Bochenek

Activities: Black Shift had a total of 99 calls. 43 were fire related, 51 were EMS calls, 5 service call.

Incidents/Events of Note: Engine 213 responded to change of quarters in Maywood for a second extra alarm church fire.

Shift Training: Black shift conducted 193.5 hours of fire related training this month and 12 hours of EMS training for a total of 205.5 hours of training. Some of the fire training can be considered cross training between fire and EMS, but for categorization purposes it was placed under fire training. That is an average of 34.25 hours per LT and firefighter/paramedics. Hazmat training, Quick drills, driver training, SCBA maze, and preplan reviews were conducted this month. 4 of 6 Black shifters attended the TECC class in Orland Park. This class provided 2 days of training for managing and providing care in an active shooter situation.

Inspections: Several inspections and multiple re-inspections were completed. 1 initial inspection remains.

Red Shift Report: Lt. Smith

Activities: For the month of December, Red Shift had a total of 63 calls. 26 of the calls were fire related. There were 31 EMS calls and 6 service calls.

Incidents/Events of Note: On December 20th, Red Shift responded to the structure fire at 7212 Oak Ave. Dispatch reported that the caller sees smoke on the 4th floor. River Forest units arrived on scene investigated and found smoke in the 4th floor hallway. The engine company went up a ladder onto the roof to inspect the elevator room and found a burnt elevator motor. The elevator was shut down while the positive pressure ventilation fan was used to ventilate smoke from the building.

On December 26th, Red Shift responded to a structure fire at 1642 S. 15th Ave, Maywood. Engine 213 arrived on scene and was given the assignment to conduct a primary search in the basement of a two-story church, heavily involved in fire. Engine 213 was conducting the primary search when they observed fire at the ceiling in the northwest corner of the basement just as Maywood Command reported all interior crews to evacuate the building. Engine 213 crew left the building to find the first floor with heavy smoke and fire conditions. Engine 213 was then assigned to supply water to Maywood Truck 502 for the duration of the incident.

On December 30th, Red Shift responded to a structure fire at 400 N. 5th Ave, Maywood. E213 arrived on scene and was assigned to overhaul of the smoke-filled basement ceiling of another large two-story church. E213 used pike poles to pull ceiling to look for fire extension.

Shift Training: Red Shift had 111.50 hours of fire related training this month and 38 hours of EMS training for a total of 149.50 hours of training. That is an average of 24.9 hours per firefighter.

Shift members completed quarterly adult and pediatric intubations training sessions. Shift members attended a CPR refresher course taught by FF Zipperich. Red Shift used structure fire videos to work on scene size-up, tactics, and firefighter safety. The Shift went to 7200-7214 Oak Ave to record hose deployment measurements from Harlem Ave to the front of each building on the property and also reviewed tactics and strategies to be used. Red Shift attended a tour of Grace Lutheran School and Church. Firefighter Doran attended Tactical Emergency Casualty Care (TECC) class in Orland Park. The 16-hour class provided paramedics skills to be used in an active shooter response. Firefighter Viera attended a 4-hour Division 11 Hazmat Drill in North Riverside.

Inspections: 4 In-Company Inspections were conducted with 6 violations noted, and 5 Re-inspections with 8 corrections noted.

Training Lt. Carter

This month the department participated in various training activities such as:

- There was no Loyola Continuing Education for December
- Several members attended a TECC (Tactical Emergency Casualty Care) class in Orland Park December 7th-8th

- Shifts performed a Pre-plan / building familiarization at Grace Lutheran Church and School

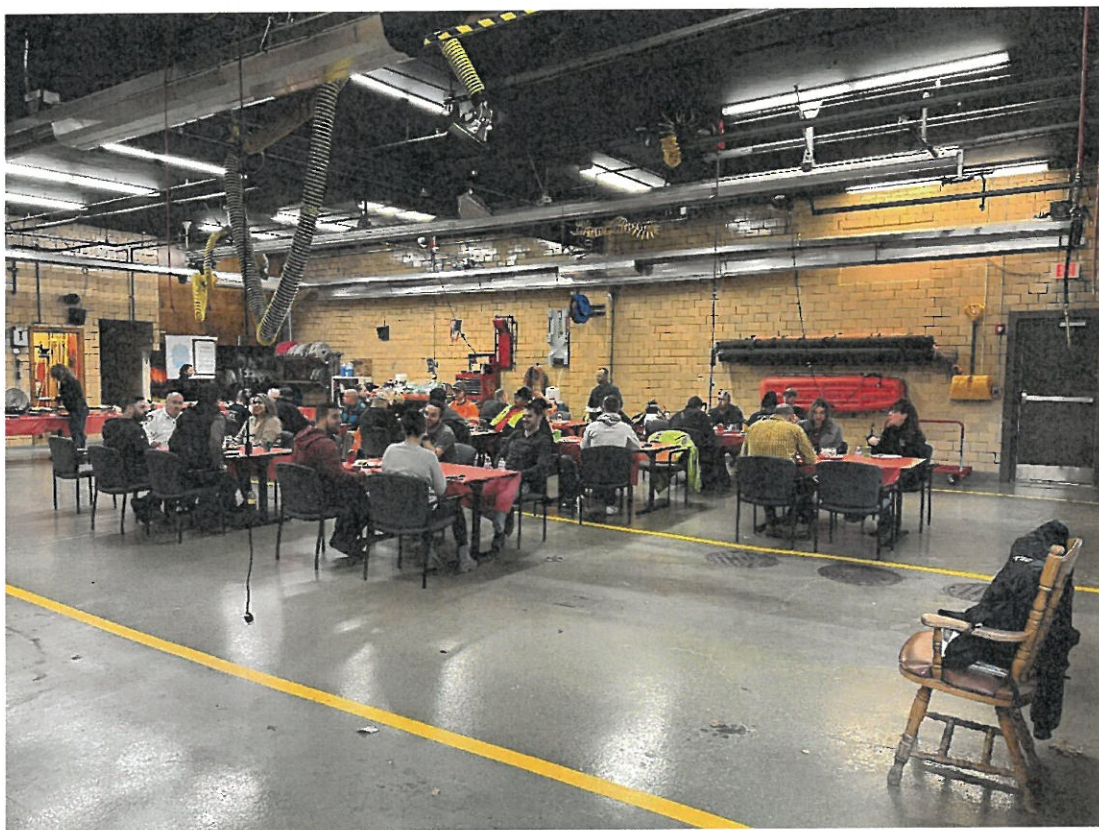

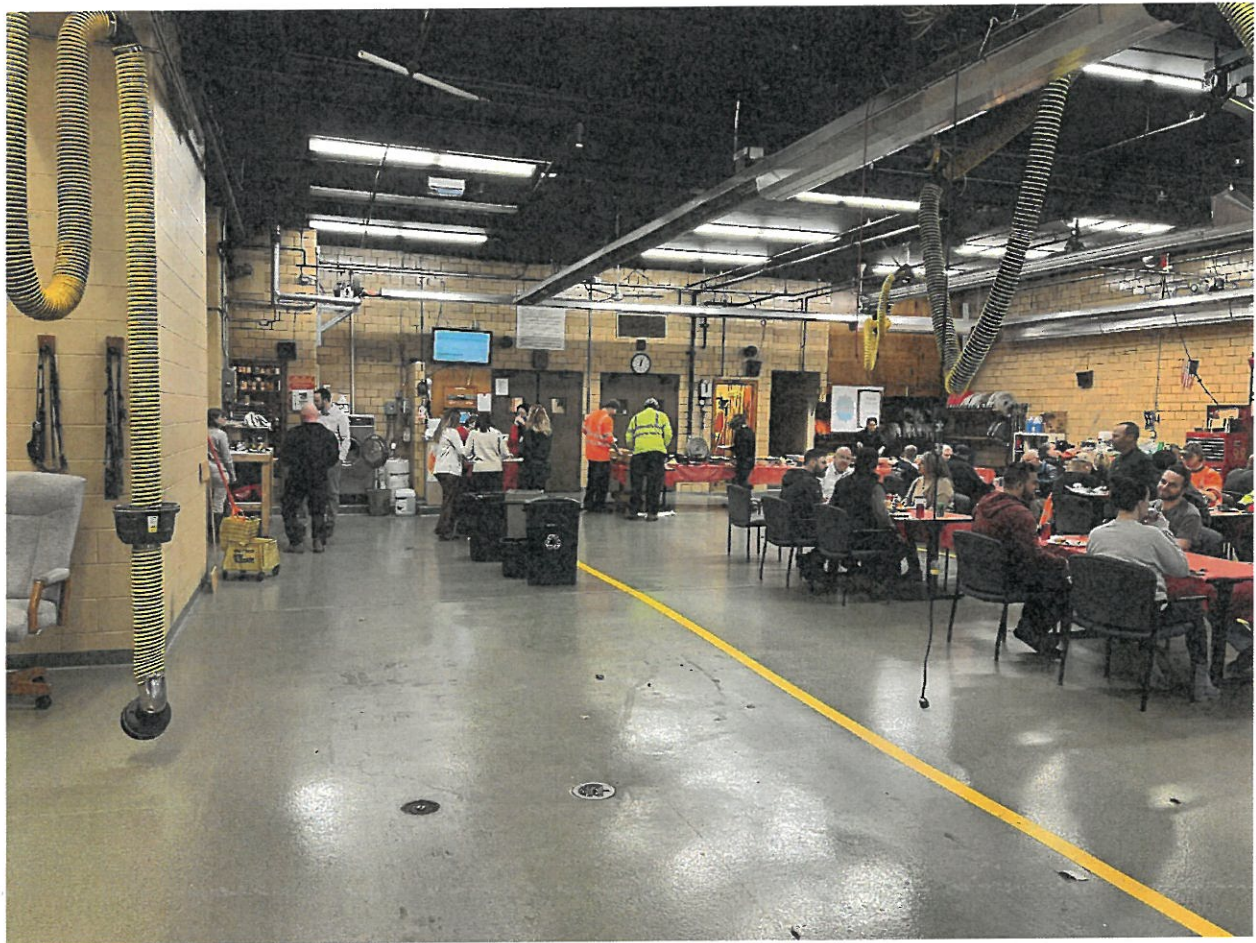

The Loyola EMS Office would like to formally recognize the excellent pre-hospital care provided by Adam Seablom, Christopher Doran, and Matthew Basa on October 24th, 2022 (Run Number 22-2223).

The call involved an 11-year-old female who was struck by a car while she was riding on a bicycle. At the time of their arrival, the crew found the patient laying in the street and poorly responsive, presenting with an obvious head injury. The crew promptly implemented spinal precautions, performed a thorough and highly accurate assessment, and initiated transport to a Level I Trauma Center. The crew transferred care to the Trauma team a mere 21 minutes after the injury occurred, and very shortly thereafter bleeding in the patient's brain was identified and successfully intervened upon. The patient regained consciousness during her hospital admission and, with the exception of some minor vision problems, has completely intact neurological function.

Mr. Seablom, Mr. Doran, and Mr. Basa demonstrated proficiency and clinical excellence in their care of this patient, and it is because of their efforts that the patient is alive and well today.

The Loyola EMS Office recognizes these individuals for their delivery of exemplary care.

A Heartfelt 'Thank You' to River Forest's Finest

River Forest resident Bushra ElSaffar, along with her American and Iraqi families, want to publicly thank the members of the River Forest Fire and Police Departments for their heroic efforts at saving Bushra's life after a terrible fire.

On the morning of March 31, 2022, Bushra was awakened by a cracking noise. She left her bedroom to investigate and found thick smoke and a raging fire in the hallway. The heat and smoke made it nearly impossible for her to breathe, but she somehow managed to move from the hallway into an adjoining room that had a landline phone. From there she called 911 but could only say a few words about the nature of the emergency. Then she lost consciousness.

The 911 dispatcher was not certain if the emergency was a fire or a burglary, so River Forest's police and fire departments were both sent to the house. The first to arrive was a police officer who had to force open a door to gain access to the locked house. Since the officer was responding to a possible burglary, he was not wearing protective breathing equipment. As a result, he inhaled some smoke from the fire for which he was briefly hospitalized.

When it became clear that the emergency was a fire, personnel from fire departments in Forest Park, Oak Park, Elmwood Park, River Grove, North Riverside, Berwyn, Cicero, and Maywood came to the scene. But the members of the River Forest Fire Department were the first to enter the house.

It is hard to imagine the difficulties and dangers the firefighters faced upon entry. The heat of the fire was so intense that the house's windows had begun to crack and were on the verge of exploding. The smoke was so thick that the light-colored interior walls were covered with what appeared to be a coat of pitch-black paint.

Despite extremely hazardous conditions and a lack of familiarity with the house, the firefighters had to search the premises because they knew that at least one person was trapped inside. And they had to act quickly, as a delay could mean the difference between life and death.

Bushra was barely breathing when the firefighters found her, and they quickly took her out of the toxic atmosphere inside the house. Once outside, however, the trauma from her exposure to smoke and heat took its toll. She stopped breathing.

Fortunately, the highly trained personnel on the scene were able to rapidly administer a variety of advanced life-saving techniques. After a few minutes, Bushra regained the ability to breathe on her own.

Once stabilized, Bushra was transported to Loyola Hospital's Burn Unit, where she was diagnosed with severe smoke inhalation. She spent two and a half weeks in intensive care at the burn unit, breathing with the help of a machine for ten days. After being released from intensive care she spent another week in a rehabilitation facility and then spent many months recovering on an outpatient basis.

Now, nearly nine months after the fire, we are pleased to report that Bushra's recovery from her harrowing experience is nearly complete. She has resumed her normal activities and hopes to return to her rebuilt home soon.

In the United States, expressions of appreciation for the work of first responders is so common that it is almost routine. But the actions of the emergency responders from River Forest and nearby suburbs were hardly routine.

Exhibiting great skill, professionalism, and bravery, a group of people who had never met Bushra put themselves at risk in order to save her life. We are fortunate to have such professionals serving the people of River Forest, and we are profoundly grateful for their efforts.
