Chairperson Vazquez stated he attended the Mayors Metropolitan Caucus (MMC) Age-Friendly Collaborative meeting on July 2. He stated that the top survey responses the MMC received were housing options in the community, transportation and connectivity, housing and ability to age in their current home, improving communications, managing the digital divide, and social engagement.
