
Dear Traffic and Safety Commission,

My name is Tetyana Pytel and I am a resident at Norway House Condominiums in River Forest. I am the association president for Norway House and am writing to you on behalf of the board to request a permitted parking zone be created in front of our building. Specifically, we would like the zone to be located on the east side of Monroe Avenue, stretching from North Avenue, to the driveway marking the end of our complexes and the beginning of individual homes.

I am making this request due to the challenging situation many of our residents are currently facing. Many residents in the building, myself included, do not have deeded parking spaces. This has forced us to look for alternative places to leave our vehicles. Until very recently, we were able to use the Fresh Thyme parking lot overnight, however Fresh Thyme has decided they will no longer allow this. Likewise, many of us rent spaces next door at the Montessori School, however, they are currently at capacity and have no more spaces to rent. In recent days, several of us have received tickets along Monroe simply because we have no other alternative and nowhere else to park. We would like to request that the Village of River Forest create a permitted parking area for us as outlined above. We would also ask that this area is designated specifically for those of us who live in this complex, with only those residing in our condominium complexes (Norway House and Monroe House) being able to purchase a permit. Likewise the area should have no time restrictions or limitations for those who possess the permit. We are happy to pay a yearly fee for this permit as we feel this would be a fair compromise.

While we understand why certain rules and regulations are in place, we feel the inability to park overnight in River Forest has created significant struggles for all of us. We hope you consider this potential compromise and help us create a much needed solution to this problem. ### MEMORANDUM

SUBJECT: Right Turn Prohibition – Greenfield and LeMoyne Streets @ Harlem Avenue

**Issue**: At the January 20, 2021 Traffic and Safety Commission meeting, the Traffic and Safety Commission (Commission) recommended that eastbound traffic on Greenfield and LeMoyne Streets be required to turn south onto Harlem Avenue between 7:00am and 9:00am and again between 4:00pm and 6:00pm. It was also requested that the item be placed on the March 17, 2021 meeting agenda to allow for increased levels of notification and public participation.

**Analysis**: Resident concerns were brought to the Commission regarding the safety of left-hand turns at these two intersections, especially during rush hours. Previous discussion indicated support for requiring right-turns only for eastbound traffic as it approaches these intersections. It was also suggested that the restrictions incorporate applicable timeframes to match the left-turn prohibitions for northbound Harlem Avenue traffic as it approaches these same intersections.

**Recommendation:** Staff is seeking the Traffic and Safety Commission's recommendation for this item, which will then be brought to the Village Board for consideration.
