# Message from the Village President



Dear River Forest Residents,

#### COVID-19 Vaccine

The Village will continue to share all vaccine distribution information with residents as we receive it from the Cook County Department of Public Health (CCDPH). For more information, please reference the updates I provided in past Special E-News editions by clicking <u>here</u>.

Triton College is now open as a large-scale vaccination site, operated by Cook County. Vaccinations at all Cook County Health sites, including Triton, **are provided by appointment only**. Appointments can be made at <u>vaccine.cookcountyil.gov</u>. Individuals without internet access or who need assistance scheduling can call (833) 308-1988 (from 7am to 7pm, Monday - Friday).

COVID-19 vaccinations are being distributed to people in Phases 1a and 1b. The distribution of vaccinations is being done in a phased approach based on vaccine availability, using guidance from local, state, and national public health authorities.

Please be aware that currently there are far more people eligible to get the vaccine than there are available vaccine doses. More than three million people in Illinois are now eligible for the vaccine, and the state's weekly shipment has been fewer than 100,000 doses in past weeks. **Your patience over the next few weeks is greatly appreciated.** 

Phase 1b includes:

- Individuals 65 and older
- Frontline essential workers, including:
  - First responders (firefighters, police)
  - Educators (teachers, support staff, daycare)
  - Food & agriculture workers
  - Manufacturing workers
  - Corrections workers
  - U.S. postal service workers
  - Public transit workers
  - Grocery store workers

There are currently four channels to receive the vaccination:

- Health Care Providers Your primary care provider, health clinic, or hospital where you have gotten medical care in the past
- Pharmacies Such as some Jewel, Walgreens, Walmart, and Mariano's pharmacies
- Dedicated Vaccination Sites See the State of Illinois map
- Employers Your employer should be reaching out to you if/when available

According to officials at CCDPH, residents that sign up through <u>the portal</u> and who are eligible to receive the vaccine, will receive email notifications about appointments that are available at sites nearest to them. Residents are also encouraged to

check back on the County website (using the link provided in the confirmation email) to check for available appointments at other County facilities, including Triton College, or with their private partners such as Jewel or Walgreens in River Forest.

The Illinois Department of Public Health (IDPH) and CCDPH are working to continue to add vaccination sites. The IDPH released this <u>press release</u> about those locations. IDPH officials note, "While we are working to increase the number of vaccines administered daily, we are limited by the amount of vaccine available and allocated by the federal government. Vaccinations are available only by appointment at this time and we encourage people to check back frequently for open appointments. Until the supply is increased, there will be a great demand and we ask people to be patient. Individuals should be signing up for an appointment to receive their second dose while they are getting their first vaccination."

#### COVID-19 Cases

Between Sunday, January 24, and Saturday, January 30, River Forest had 18 new positive cases; 356 tests were completed, resulting in a positivity rate of 5.1%. The week before, from Sunday, January 17, to Saturday, January 23, there were 17 new positive cases of COVID-19; 305 tests were completed, resulting in a positivity rate of 5.6%. #### **COVID-19 Restrictions**

Currently, all regions in Illinois are in <u>Phase 4</u>. However, CCDPH has issued <u>Mitigation Order 2021-01</u>. River Forest is under the jurisdiction of CCDPH and is subject to these mitigation measures. To review the mitigation measures in their entirety, please click <u>here</u>. Under Cook County Mitigation Order 2021-01, indoor restaurant and bar service is limited to the lesser of 25% room capacity or 25 persons.

#### COVID-19 Testing

Residents who have symptoms of COVID-19 or who have been exposed to confirmed cases of COVID-19 should quarantine and get tested. Residents are encouraged to contact their primary care physicians to coordinate testing needs. # **Roy Strom Acquired by Lakeshore Recycling Services**

The Village's waste hauler Roy Strom was recently acquired by Lakeshore Recycling Systems. There are no anticipated changes to the current collection agreement with Roy Strom and there will be no disruption to current services.

## Snow Removal - Know the Code

Residents are asked to review the below Village code items related to snow removal, as well as aid the Fire Department by making sure that <u>hydrants are accessible</u> in case of an emergency.

• Village code requires residents and business owners to remove snow and ice from sidewalks in front of and adjacent to their property within 24 hours after an event. If you are on a corner lot, you are responsible for removing snow on all sidewalks adjacent to your property.

• Snow or ice frozen on sidewalks that cannot be removed without injury to the pavement should be treated with an abrasive material until weather permits further clean-up.

• Parking on Village streets is prohibited after snow exceeds two inches in depth, and for an eight hour period following the cessation of the snowfall.

• Snow removal contractors are prohibited from using snow blowers between the hours of 1AM and 5AM.

• The placement of snow or ice on any Village owned street, alley or sidewalk is prohibited.

# **Property Taxes**

Due to Covid-19, all exemptions will automatically renew for only the year 2020. Exemptions are taken into account on the 2nd installment payment. This includes: Homeowners, Senior, Senior Freeze, Disabled Veterans and Disabled.

Homeowners who turn 66 years of age in the year 2021 will need to file for a Senior Prime exemption. Exemption forms should be available sometime in late February. The Assessor's Office will be mailing the forms to residents who have contacted the Office regarding this exemption.

First installment tax bills are available online. First installment tax bills are estimated tax bills. They are 55% of the total amount paid in the previous year. Due to Covid-19, both the 1st and 2nd installment tax bills will have a 2 month penalty free grace period in the payment schedule.
