

RESOLUTION NO. 2011-16

A RESOLUTION PROVIDING AN HONORARY DESIGNATION OF THE <u>700 BLOCK OF BONNIE BRAE PLACE AS "LEMONAID PLACE"</u>

WHEREAS, the 700 Bonnie Brae LemonAid Stand was established in 2002 in memory of the September 11th attacks on the World Trade Center and the Pentagon in an effort to call to remember this day by doing something positive in the community; and

WHEREAS, it was decided to hold a LemonAid Stand and to donate the proceeds to a local charity benefiting children; and,

WHEREAS, approximately 75 Bonnie Brae residents participate in one way or another to the organization and success of the LemonAid Stand; and

WHEREAS, each year, 700 Bonnie Brae families nominate a local organization that support children to be the beneficiary and a representative of the beneficiary organization gives a presentation to the children to explain their program and how the money will be used; and

WHEREAS, the LemonAid Stand has donated more than \$36,000 to local children's charities since its inception; and

WHEREAS, the LemonAid Stand has become a local tradition as a day to remember a very tragic event with a very positive one. The families of Bonnie Brae have grown by reaching out to the community; the community has responded by enthusiastically supporting the event, and the local charities have felt tremendous support by the community they serve.

NOW, THERFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of River Forest, Cook County, Illinois that the Board, for its members and the citizens of the Village of River Forest, extend thanks and appreciation to the residents of the 700 block of Bonnie Brae and present this Resolution to them as a symbol of gratitude for the high quality of community service rendered.

BE IT FURTHER RESOLVED that:

SECTION 1. The 700 block of Bonnie Brae Place shall have a secondary designation as "LemonAid Place."

SECTION 2. The Board of Trustees requests that the Village place an honorary street name sign at the intersection of Bonnie Brae Place and Chicago Avenue, which shall reflect the "LemonAid Place" designation.

SECTION 3. By this Resolution, the Board of Trustees does not intend to affect any existing or future signage that reflects the secondary designation of Bonnie Brae Place, with the exception of the honorary sign described in Section 2 of this Resolution.

SECTION 4: This Resolution shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
