**PETITION FOR RIVER FOREST BINDING REFERENDUM**

We, the undersigned, registered voters within River Forest, Cook County, State of Illinois, pursuant to the Illinois Election Code, 10 ILCS 5/28-1 *et seq.* PETITION the governing body of the County of Cook in the State of Illinois, that the following advisory question of public policy be placed on the ballot and submitted to the voters of River Forest for their approval or disapproval, by referendum at the Consolidated Election to be held on April 1, 2025.

Shall the Village of River Forest, after the April 1, 2025, Consolidated Election, enact term limits for the elected offices of Village President, Village Clerk, and the six (6) Village Trustees for no more than two (2) four-year (4-year ) terms total as follows: for each of three (3) Trustees beginning with the April 3, 2027, Consolidated election, and for the Village President, Village Clerk, and three (3) Trustees starting with the April 6, 2029, Consolidated election?
