Message from the Village President

Dear River Forest Residents.

Last week, I provided an update on the vaccine distribution information that has been shared from the Cook County Department of Public Health (CCDPH) and the Illinois Department of Public Health (IDPH). If you have not already, please read that message by clicking here.

The CCDPH, which has jurisdiction of River Forest, is ultimately responsible for distributing vaccine doses for our residents. The Village is working with the County and other partner agencies to have the latest information and is ready to help however we can.

The CCDPH is now inviting residents to sign up to receive information about the vaccine distribution plan. This survey does not register individuals to receive the vaccination, only to receive regular updates about the availability and distribution of the vaccination. River Forest residents should click here to complete the survey.

The State of Illinois announced that in the next phase, Phase 1b, residents over the age of 65 will be eligible to receive the vaccination along with frontline essential workers as outlined by the Advisory Committee on Immunization Practices (ACIP). Click here to learn more.

CCDPH plans to provide some direct vaccinations, but most will be administered by partners, such as hospitals, other healthcare facilities (e.g. clinics, nursing homes, etc.) and retail pharmacies per federal contracts. At this time, we are still in Phase 1a, which focuses on health care workers (particularly those who treat COVID patients) and residents and staff at long-term care facilities.

The Village will continue to share all vaccine distribution information with residents. If you have questions, please review the resources below and contact your primary care physician. Between Sunday, December 27, and Saturday, January 2, River Forest had 28 new positive cases; 282 tests were completed, resulting in a positivity rate of 9.9%. The week before, from Sunday, December 20, to Saturday, December 26, there were 23 new positive cases of COVID-19; 393 tests were completed, resulting in a positivity rate of 5.9%. Free, Community-Based COVID-19 Tests

Community-based, state-run COVID-19 testing sites are open to everyone regardless of symptoms or other criteria. No appointment, doctor referral or insurance is needed, and testing is free. Village Spotlight

Did you know the River Forest Police Department holds quarterly community meetings? The meetings are intended to help keep residents informed and introduce members of the Department to the community. Department members review a range

of topics during the meetings including scams, recent crime trends, crime prevention tips, and general safety tips. Representatives from community organizations and government agencies are also often featured as guest speakers to discuss the programs and services they offer and provide subject matter expertise. These meetings also offer an open forum for residents to ask questions to members of the Department. The next Community Safety Meeting is scheduled for Wednesday, 1/27 at 6PM and will be held virtually. Meeting details will be published to the Village calendar here in advance of the meeting. A recording of the meeting will also be available for those unable to attend at the time.

Snow Removal

Please do your part to be a good neighbor - especially during snow events. Remember to:

- **Help others** if you are able, lend a hand in helping your neighbors shovel snow, especially if they are elderly or in need.
- Shovel the sidewalk Village Code requires residents and business owners to remove snow and ice from sidewalks in front of and adjacent to their property within 24 hours after an event. Snow or ice frozen on sidewalks that cannot be removed without injury to the pavement should be treated with an abrasive material until weather permits further clean-up.
- Not park on the street parking is not permitted on any Village street after two inches of snow or more has accumulated on the street, and for up to eight hours after the snowfall ends, to allow snow plows to safely clear the street.
- **Shovel hydrants** if you have a fire hydrant near your home, help first responders by clearing snow to make sure that they have a clear path.
- **Don't dump snow in streets, alleys, or sidewalks** the placement of snow or ice on any Village owned street, alley or sidewalk is prohibited.

Village Hall Closure

Village Hall will be closed on Monday, January 18 in observance of Dr. Martin Luther King, Jr. Day. Garbage service will not be affected.

Compost Your Live Christmas Trees, Wreathes and Garland through Roy Strom



Christmas trees, wreathes, garland and other holiday compostable decorations will be collected every Tuesday during the month of January by Roy Strom. The holiday greens must be placed on the parkway prior to 7AM on these days. Please be sure to remove all lights, tinsel, ornaments, metal hangers, plastic material and stands prior to placing at the curb for pick-up as these materials will prevent the item from being properly composted. All compost made from these items will be distributed as part of compost shared each April with Roy Strom customers who pay for curbside composting. Got New Gadgets as Gifts? Recycle Old Electronics and Help Others at the Same Time

Before the pandemic, all residents in the West Cook County Solid Waste Agency Region (which includes River Forest) were able to drop off old electronics at the Village of Burr Ridge Public Works Department. That facility is operated by a not-for-profit company called eWorks, which was established in 2009 to create employment opportunities for people with disabilities. eWorks achieves this mission by providing competitive recycling, refurbishment and resale services of all types of office and industrial technologies and consumer electronics.

Because some municipal facilities have been closed during the pandemic, eWorks has opened up their facility in Elk Grove Village (1201 Estes St) to the public to collect electronics directly from residents. TOWNSHIP ASSESSOR SPOTLIGHT

Exemptions

Homeowner and Senior Exemptions renew automatically. **Due to COVID-19**, **for 2021 only**, the Senior Freeze, Veterans with Disabilities, and Persons with Disabilities Exemptions will automatically renew and appear on your second installment tax bill. Property Tax Bills

The first installment tax bills have been posted to the Cook County Treasurer's <u>website</u>. The first installment is always 55% of the total previous year's tax bill and is due Tuesday, March 2, 2021. **Due to COVID-19 they have waived late payment penalties for two months.** All assessment changes due to the triennial reassessment and all exemptions will be taken into account on your second installment tax bill.

Tax bills may be paid online OR at Chase Bank OR by sending a check to the Cook County Treasurer.
