

Thank you for taking the time to read the Village's E-News. These messages are sent approximately once per month and include timely information regarding Village events, news and other useful information. We strive to keep the content brief and relevant to the issues that matter most to the community.

### ComEd Outages

According to representatives at ComEd, approximately 218 River Forest customers remain without power due to the storm on Tuesday, June 9, 2020. 1,035 customers have already been restored. ComEd crews continue to work to restore all customers. For updated information and numbers of outages, please view the <u>ComEd Outage Status map</u>.

#### **Storm Damage**

In the event a tree is damaged by storm activity, and for the first two weeks following a storm event, residents may place fallen tree limbs and branches that are four inches or greater in diameter, regardless of length, in the parkway to be collected by Village crews. All smaller materials (less than four inches in diameter) should be disposed of in the regular yard waste program utilizing yard waste bags or brush tags. Do not place these materials in the street. If it is not practical to prepare materials for collection under the regular yard waste program, residents may contact a tree care company or waste disposal company to arrange for a special collection of the material. All contractors must be licensed and bonded with the Village of River Forest.

### Watch the Weather

Being prepared includes staying informed on the weather. Now more than ever before, residents are able to do this with weather apps that provide updates, websites, or even radio and television. Utilize a resource such as weather.com, the <u>National Weather Service</u>, the <u>Chicago Tribune</u>, or any other weather radar provider to stay in the know and stay prepared.

### Village Spotlight

The Village's new 100% renewable EcoGreen Aggregation Program with MC Squared offsets carbon emissions by purchasing Renewable Energy Credits (RECs) from energy supplied by wind farms in the Midwest. Approximately half of the ComEd accounts in the 🛧 🛧 Backed by Wind Energy 🛧 🛧 🛧 Village are eligible for this program and will receive notice of enrollment and the value of



renewable energy for the community. There are no savings or additional cost to residents to participate in the program since it will match the ComEd rate, and the Village will receive \$30,000 in civic contribution funds to use towards sustainable initiatives. Click here to read the FAQ.

#### 2020-2021 Vehicle Stickers

Vehicle stickers for 2020-2021 are now available for purchase. Due to the unprecedented circumstances presented by the COVID-19 pandemic, the deadline for purchasing the vehicle stickers has been delayed by 60 days. The stated deadline of July 14 on the application has been extended to September 14, 2020. In order to avoid late fees and citations, vehicle stickers must be purchased and affixed to your windshield by 9/14, 2020. All vehicles registered in the State of Illinois with a River Forest address must also be registered with the Village through the purchase of a vehicle sticker license. Payment may be made as follows:

- Online at the Village Website by clicking here.
- By mail using the envelope received from the Village (the application can also be downloaded here).
- Drop off your application in the green bin in front of Village Hall.

If you choose any one of these no contact payment options, the vehicle sticker will be delivered to you via US Mail.

Stickers are \$45 for passenger vehicles and \$25 for motorcycles, antique vehicles and senior citizens (one senior citizen vehicle sticker per household). Vehicle sticker applications were recently mailed. If you receive an application for a vehicle that you no longer own or a duplicate application, please notify the Village by either calling, or returning the application noting the vehicle's status in the enclosed envelope, so that the vehicle will be removed from our records. #### Fireworks & Grilling Safety

The River Forest Fire Department in conjunction with the Illinois State Fire Marshal wants to remind citizens that fireworks are not all fun and games. ### Summer Learning Opportunities at District 90 with River Forest Public Library

District 90, in collaboration with the River Forest Public Library, will be offering summer learning opportunities for students during the summer months. These summer activities are in lieu of the in-person summer school classes that are usually

held. Offered to District students in rising 1st through 8th grades, these summer learning opportunities will be conducted online. These opportunities include book clubs, math activities, and STEM lessons. All are designed to help students maintain their learning trajectory. #### District 90 Supports Emergency Childcare at West Cook YMCA

District 90 is participating in a community effort to help support the many healthcare personnel, first responders, and essential employees who live and work in our local communities. In collaboration with the West Cook YMCA, District 90 will provide a site for the YMCA's Emergency Childcare Center (ECC), which will be housed at the Lincoln Elementary School. The program will begin on 6/15 and will conclude on 8/7. The ECC program will be housed in a designated wing of the building and will adhere to the strict health and safety guidelines established by the Centers for Disease Control and Prevention (CDC) and the Illinois Department of Public Health (IDPH). These guidelines address numerous issues, including social distancing, limited student-teacher ratios, daily health screenings, and rigorous facility cleaning and disinfecting protocols.
