#### Message from the Village President



Dear River Forest Residents,

The Village of River Forest is working with local officials and community partners to monitor the impact of the novel coronavirus (COVID-19). On Monday, March 2, the Village sent out a Special E-News email explaining more about COVID-19 and what we have been doing to keep our community informed. To read more, click <u>here</u>. Since that time, the Federal Government has passed legislation that will provide funding in the event the Village incurs costs in response to coronavirus. If you forwarded

our email to someone, please consider asking them to sign up for the Village's E-News by clicking <u>here</u>. The Village will continue to monitor the situation and send out more information as the need arises.

This month the Village Board and I are moving into what is usually a busy time as we start to put the finishing touches on next year's budget.

On our agenda for our March 9 meeting, we will discuss a new Roy Strom waste hauling contract, which will include an updated electronics recycling component.

At our Special Village Board of Trustees meeting on March 30, we will review and consider recommendations from our long-awaited parking study. Additionally, we will discuss clean energy aggregation for our Village where we hope to find ways to provide clean energy at lower cost to our residents.

Until then, here are a few things we took up at the Village Board of Trustees meeting in February.

The deer management ad-hoc committee appointees were approved by a 5-1 vote. Eleven residents, along with two Trustees, will serve on the committee. After discussion, an additional two more members will be named at our March 9 meeting. A report and recommendations will be reviewed by Trustees this fall. The board also anticipates recommendations coming from the committee before the final report is presented. Information on this issue is posted on our <u>website</u>.

The Board also approved formation of an Age-Friendly Advisory Committee, the second step toward making River Forest an official part of the <u>AARP Network of Age-Friendly States and Communities</u>. The Village was accepted into the Network last November. I will appoint, with the



advice and consent of the Village Trustees, a seven-member committee to undertake this important responsibility. If you are interested, please fill

out an application, which you can find here. We strongly encourage our senior residents to apply so that they are better represented in this process. The committee will meet over the next two years and come back with an Age-Friendly River Forest action plan. I would like to thank Trustee Vazquez for his leadership in this effort.

The Trustees and I signed a letter of commitment to join the PlanItGreen initiative to pursue 100% renewable electricity by 2050. We would like to thank Julie Moller and the Sustainability Commission for bringing this forward and for all of their hard work in helping make River Forest a healthier, more sustainable community.

Residents can find out more about the sustainability efforts in River Forest, Oak Park and the League of Women Voters during the Second Tuesday Forum, at 9:30 a.m., Tuesday, March 10 at the Nineteenth Century Club, 178 Forest Ave., Oak Park. The event is sponsored by the Environmental Committee of the local League of Women Voters and Julie Moller, Chair of our Sustainability Commission will make a presentation.



RIVER FOREST Census Day is April 1. As the date approaches, River Forest - and 2020 CENSUS / the entire nation - will continue to prepare for the 2020 Census. Our participation is vital for it ensures that we are fairly represented at all levels of government, and that River Forest,

Cook County and the State of Illinois receive a fair share of federal funding to support a wide variety of projects and services. I would like to thank Trustee Bachner for her leadership in this effort.

In April, we will discuss and adopt the 2020-2021 budget.

Finally, congratulations to our Roosevelt Middle School students Marin Chalmers and Daniela Arezina, both in 7th grade, who won awards and recognition at the One Earth Young Filmmakers Contest for their animated film "Walking for a Happier Earth." Also, congratulations to Samantha Older, a 7th grader at Roosevelt, who received an honorable mention for her film, "The Shortage of Helium." #### Imagine OPRF Project 1 Breaks Ground in June

During nearly two years of facilities master planning, a rather surprising theme emerged from the input collected: students repeatedly said that they needed spaces that would allow them to spend more time at school to study, collaborate on projects, and socialize during down time. That is exactly what they will have in the centralized, secure Student Resource Center (SRC) that breaks ground this June. Funding for the project, which has a cost of \$32,631,500, will come from existing cash reserves, thereby avoiding a tax increase to property owners and preserving the district's debt-free status.
