Illinois Bike Safety Laws

- Cyclists must obey same "Rules of the Road" as motor vehicles.
- This includes proper lane usage and obeying traffic signals.
- Must stay to the right.
- No more than 2 riders abreast.
- At least one hand must be on handlebars.
- When riding at night, bikes must have white light on front and red reflector on rear.



River Forest Bike Safety Laws

- All children under age 16 must wear a properly fitting bicycle helmet.
- No restriction on sidewalk riding— it is recommended that children ride on sidewalk and adults ride in street.
- Sidewalk cyclists are considered "pedestrians" under state law, but must yield to pedestrians.
- Parked bikes may not obstruct a public way.

IL General Assembly Public Act 101-002 TOBACCO 2



IL General Assembly Public Act 101-002

- Effective July 1st, 2019
- Raised the legal age from 18 to 21 for purchase and sale of tobacco.
- Removed penalties for possession of tobacco for persons under 21.

River Forest Local Ordinance

 Section <u>8-6-22</u> of the Village Code was amended by the village board to accommodate new state law.





8-6-22 Section 2 A: Definitions

"Tobacco: Any substance containing tobacco leaf, including, but not limited to, cigarettes, cigars, pipe tobacco, snuff, chewing tobacco or dipping tobacco, and any product or device not consisting of or containing tobacco that provides for the ingestion into the body of nicotine whether by chewing, smoking, absorbing, dissolving, inhaling, snorting, sniffing, or any other means including, but not by way of limitation, what is commonly referred to as e-cigarettes or vaping."

8-6-22 Section 2 B: Prohibited

1. "No person under the age of twenty-one (21) years shall knowingly possess or use tobacco, in any of its forms, of twenty-one (21) years under the direct supervision of the parent or legal guardian of such person in the privacy of the parent's or guardian's home shall not be prohibited."



8-6-22 Section 2 B: Prohibited

2. "It shall be unlawful for any person under the age of twenty-one (21) years to purchase tobacco, or to misrepresent his identity or age, or to use any false or altered identification for the purpose of purchasing tobacco."

8-6-22 Section 2 B: Prohibited

3. "It shall be unlawful for any person to sell, offer for sale, give away or deliver tobacco to any person under the age of twenty-one (21) years. Signs informing the public of the age restrictions provided for herein shall be posted by every seller of tobacco at or near every display of tobacco and on or upon every vending machine which offers tobacco for sale. Each such sign shall be plainly visible and shall state:

"THE SALE OF TOBACCO TO PERSONS UNDER TWENTY-ONE YEARS OF AGE IS PROHIBITED BY LAW"

Mission: To prevent deaths and reduce injuries on our roadways due to excessive speeding.

Goal: To heighten public awareness of the dangers of excessive speed through education and involvement in our community.

Facts

462 lives were lost in 2017 on Illinois roadways due to speeding.

The higher the speed at impact, the more severe the injuries sustained. 37% of the speed-related crashes result in injuries.

When speeding there is a greater chance that other road users will misjudge how fast you are traveling.

Speeding extends the distance required to stop a vehicle in emergency situations.

Speeding reduces a driver's ability to navigate safely around curves or objects in the roadway.

When a pedestrian is hit by a car at 20 MPH there is a I0% likelihood of being killed, at a speed of 30 MPH the percentage increases to a 50% likelihood of being killed.





Take the Pledge

Make a commitment today to always drive at a safe speed to end senseless fatalities on our roadways. One third of all traffic deaths are due to speeding.

Pledge to:

- Always drive at a safe speed.
- Remember that speed limits are a maximum not a target.
- · Set realistic journey times.
- Be a role model by speaking up when someone is driving at unsafe speeds.

- It's none of my business.
- Someone else will report it.
- The Police are too busy.
- That noise was probably nothing.

- You may be the next victim.
- What if they don't?

- Why did it attract your attention?

When?

- If you see suspicious activity...call!
- Don't rely on someone else to act.
- Don't waste precious time consulting with someone else first.



What to Say

- 1. Describe why you are calling.
- 2. Name, address, and phone number.
- 3. Give detailed suspect/vehicle description.

- 5. Stay calm, remain on the phone to give additional information.
